- Paid-up members can participate in any Leyland u3a Interest Groups, AGM & monthly meetings.
- A National Magazine, Web & Blog Site, Facebook Page, Newsletters and Membership Handouts are available to keep members aware of our National and Lu3a activities.
- Lu3a membership runs from 1<sup>st</sup> April to 31<sup>st</sup> March each year and is payable in full whatever time of year someone applies or renews. No refund will be given for early termination of membership.
- New members joining after 1st January paying the FULL year's subscription will have membership until 31st March the following year or before the annual renewal fee is due.
- The annual renewal fee must be paid by 31st July or a new application may have to be made unless extended by permission of the Membership Secretary.
